- Krista made a motion to approve \$2,300 for the Hands On Ink Club (570325). The board would like to see their business plan before allocating additional funds. Caledon seconded. Motion passed.
- Sam made a motion to fund landscaping and dental clubs without presenting to the board, the
  motion was not seconded. Caledon made a motion to review the requests from LNDC and DNTL
  and decide on funding, Ariel seconded. Motion failed. Sue made a motion to review the
  Landscaping and Dental Club requests when a representative from those clubs can attend to
  present their request to the Board. Asani seconded. Motion passed.
