-Student suggestion: Extend hours for the time being and also send out a survey to see student interest/to see what we would need long-term.

-Francis rephrased motion: Motion is based on tutoring hours at HTC BPC. Some students are not able to get the help they need because they work. By the time they are available to get help from the tutoring center, tutoring center is already closed for the day.

-Question/suggestion: We can have the tutoring center open with extended hours by appointment only?

-Question: Can appointments be made after 4pm?
